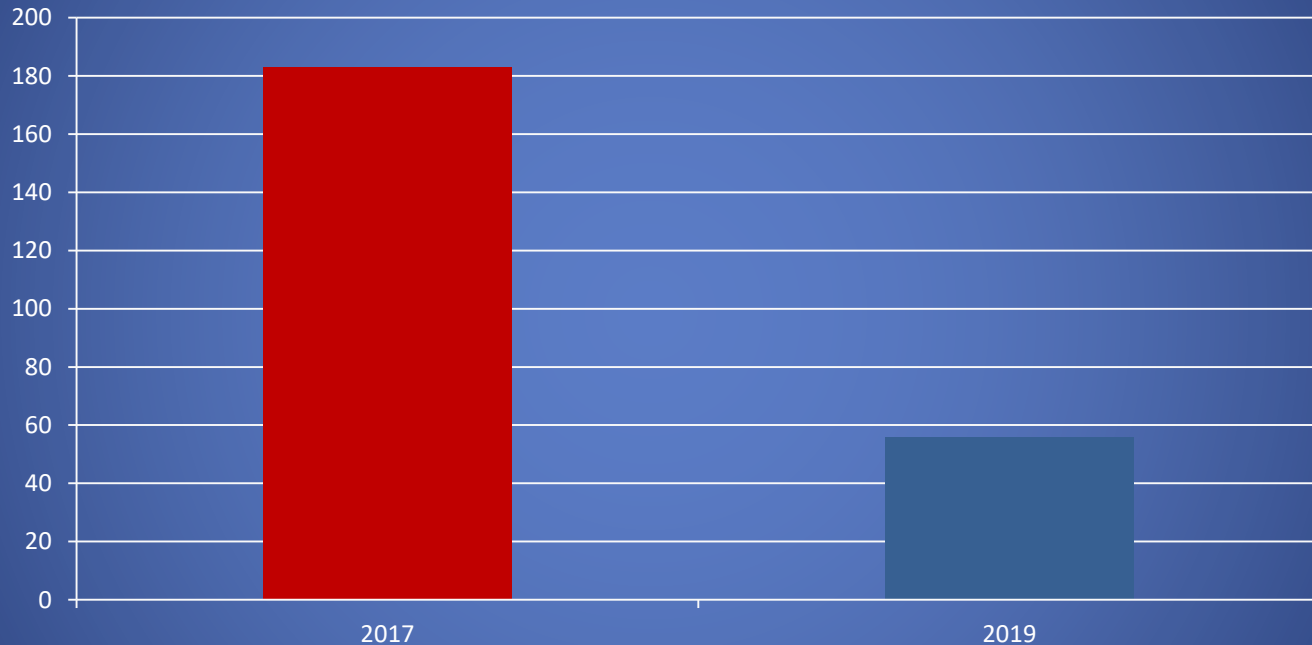

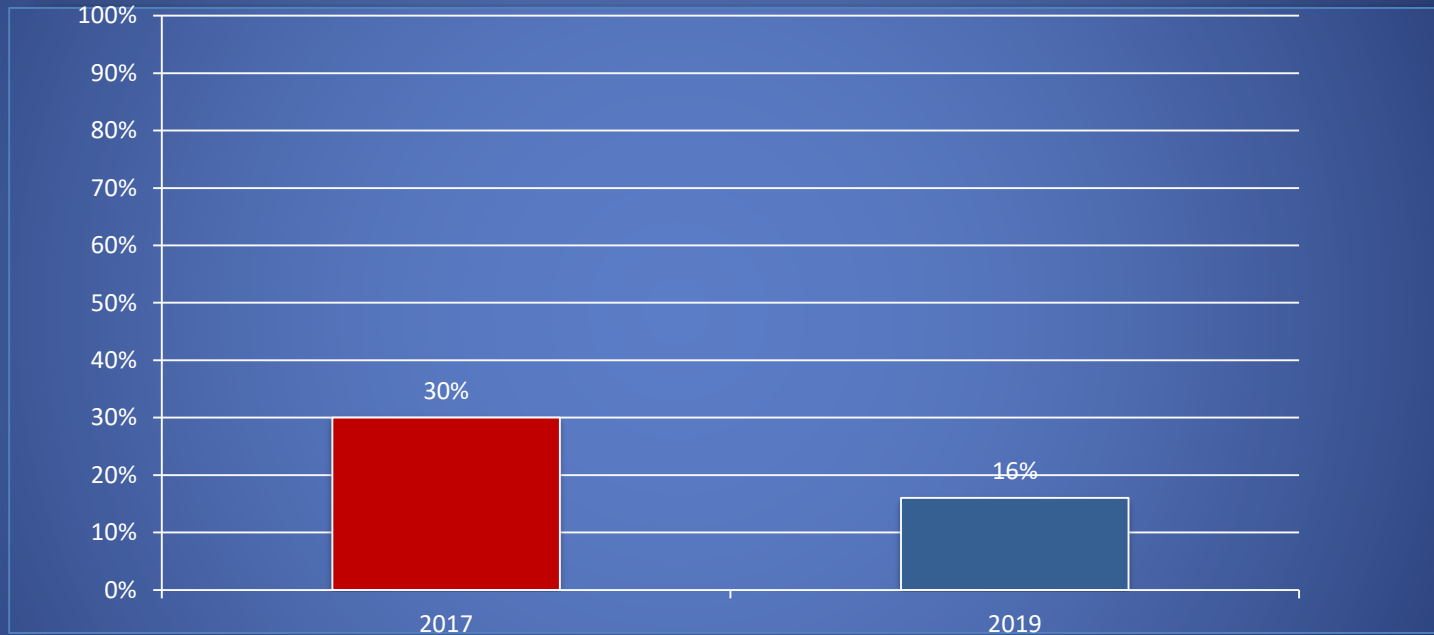


Issuance To Adjudication
